Because the deadline 7/31 falls on a Sunday it has been extended to the next business day.

Aug 15, 2016 E-85 Mon		Last day to withdraw Candidate Statements, unless there an extension of the nomination period. Withdrawal of candidate statements must be made in writing to the city Clerk (E.C. 13307)
